## WHO 'S IN CHARGE HERE?

In the forward of Gary DeMar's book *Ruler of Nations* Dr. John Whitehead wrote: There are "three types of government established by God---the family, the church, and the civil government, each given its own specific and *limited* jurisdiction. These three governments were intended to work cooperatively with one another under the ultimate authority of God. Unfortunately, that relationship of cooperation has been replaced by one of competition. The state, having severed itself from all accountabilities to God, has increasingly seized control of areas that rightfully belong to the family or the church. But equally damaging is the way in which the church and family have relinquished many of their responsibilities to the government bureaucracy."

Our question is "Who's in charge of these three establishments?" or who's the Authority in each of them? It is with trepidation that we use the word "authority" but authority is to be viewed in the light of the fact that God is creator of all things and is the judge who has given Jesus "all authority to execute Judgment, because he is the son of man" (John 5:27), and the words of Jesus when he made the statement: "All authority has been given to me both in heaven and earth" (Matt 28:18). Therefore these three institutions are under the authority of Jesus Christ who establishes, through the Apostles, the conduct of the family (Eph. 5:20-6:4; Col. 3:18-21) and upholds and applies Old Testament regulations concerning the family (Matt. 5:31, 32; 19:4; Mark 10:6-16). He is the head of the church (Eph. 5:23) and "head over all things to the church, which is his body" (Eph. 1:22, 23). He is "the ruler of the kings of the earth" (Rev.1:5).

Marriage was created by God, thus making it a sacred institution: "The Lord has been a witness between you and the wife of your youth...she is your companion and your wife by covenant" (Mal. 2:14). This means the family is not absolute nor is the center of society as many Christian writers believe. For example some say the family is the most important institute in society. God is the center of society, and the proper role of the family is covenant under God. He is the final authority in the family. Paganism can make the family the center of society and leave God out, but this makes the family a god. That God is to be the central authority in the family is seen in the first family created by God (Gen. 2:18-25). Jesus applies this scripture when answering the Pharisees on the question of divorce: "Have you not read that He who created them from the beginning made them male and female, and said, 'For this cause shall a man leave his father and mother, and cleave to his wife, and the two shall become one flesh'?" (Matt. 19:4, 5). God, then, is the final authority in the family, but His authority is delegated. The Apostle Paul wrote: "I want you to understand that Christ is the head of every man, and the man is the head of a woman, and God is the head of Christ" (I Cor. 11:3). Discipline which is to reside in the home is exercised by the father: "Fathers do not provoke your children to anger but bring

them up in the discipline and instruction of the Lord" (EPH. 5:4). Deuteronomy 6:2-7 is the classic example of the father teaching his children. However, the mother's influence is seen in the family as well: "For I am mindful of the sincere faith within you, which first dwelt in your grandmother Lois, and your mother Eunice...from a child you have known the sacred scriptures which are able to give you wisdom that leads to salvation" (II Tim. 1:5; 3:15). All this says the basis of our children's education is the word of God, taught by the parents, under the authority of God. A well-established fact is the family is under attack today. The late Charles Colson stated it verily plainly in Kingdoms in Conflict. He stated: "In the West relativism has encouraged the belief that the family is a matter of convention. The traditional family has all but disintegrated in the inner city, where more than 50 percent of the children are born out of wedlock. And in the nation as a whole more than half the children are raised in one parent families. Some school textbooks even describe the family as any voluntary grouping of people living together. This attitude is reflected in our laws and court decisions, our public mores and in our crime rates." The Late Carl Henry wrote in The Modern Flight of the Family that the loss of the God-ordained role of the family leads to the "deterioration of the society then eventually the collapse of the nation." Modern society has invented and advocated all sorts of means: TV shows, books, conferences, tapes, marriage encounters and special family counseling and the like, to answer problems the family is facing. The last verse in the Old Testament gives the answer: "And I will restore the hearts of the fathers to the children and the hearts of the children to the fathers" (Mal. 4:5). Jesus fulfilled this prophesy.

God is Lord of the family, and He is also Lord of the Church, with Christ as the head and the church as his body. When he is not recognized as "head" this opens the church to attacks by demonic powers which become "Lord" and the church is unaware this is taking place. The church is created by God and Christ is the head of the church, therefore it is a "spiritual" entity not some ecclesiastical social organization. The Lord builds the church not with modern merchandising and marketing techniques to sell the church program to the masses, nor by construction of attractive edifices in a location near a growing suburb targeting an affluent clientele, nor by presenting a non-offensive, upbeat, tingling, and entertaining gospel that makes everyone feel good about themselves, but with the power of the gospel and the strength of the Word of God. The church is his body; it does not belong to its members. However, the church has been given the keys of the kingdom (Matt. 16:19) and this is manifested in the preaching of the word, and the disciplined lives of the members. Jesus condemns the lawyers for taking away the "key of knowledge" and hindering people from entering the kingdom (Luke 11:52). The church, then, possesses the key of knowledge of the kingdom which is the essential message of the church. However, this is a message we hear little abut in the average church today.

fulfill the apostolic office one had to have a part of the ministry of Christ (Acts 1:21, 22) or to have seen the Lord (I Cor. 9:1). When the last of the New Testament apostles passed away so did the gift pass away. The prophet was one who had a direct revelation from God to be spoken at a particular time and for a particular purpose. With the completion of the Word there was no further need for the prophetic office. This leaves the Evangelist (a proclaimer of the Bishop is used interchangeably with the word Pastor. The final authority and well-being of the church is the Elders (Heb. 13:7) who have the responsibility of guarding and shepherding the church (Acts 20:28; I Pet. 5:1-3). Having failed to recognize and accept the fact that the church is a covenant under God, the modern church has taken the authority from the Elder and given it to CEO's, Senior Ministers, Church Planters, Youth Minister's, and boards made up of both Elders and Deacons plus Deaconesses.

Being a part of the church is serious and not to be taken lightly. The church having the keys of the kingdom has as its first responsibility making disciples by the proclamation of the Word (Matt. 28:19, 20, Mark 16:15, Luke 24:47), and by being ambassadors of Christ who stand before the world representing Christ (II Cor. 5:20). This will not be done with the same latest initiatives found in Rick Warren's Purpose Driven Church. Instead, it will be found in the sincere and accurate preaching of the Word. The other responsibility of the church is to care for the poor and needy (Gal. 2:10; James 1:27, II thus unable to receive support from relatives, and they must meet Cor. 9:8-12). These are the two Biblical statements concerning the work of the church. What the church does or doesn't do directly should provide for their aged parents (Matt. 15:4-6).
